



SEAS: ST. EGBERT AFTER SCHOOL PROGRAM

Our SEAS program strives to blend the continuity of our program with what happens during the regular school hours at St. Egbert. The children will be held to the same standards of behavior, with the added bonus of more free time inside and out! After school hours can make a really long day so we will encourage students to play hard while outside and complete their homework as much as possible before leaving to go home. SEAS has a distinctively Christian character and reflects the school mission and values of St. Egbert Catholic School. SEAS is a safe, loving environment where children can relax, learn, and have fun!

SEAS will be open 5 days/week on days the school is **open from 2:40 PM – 5:45 PM** and on noon dismissal days from **Noon – 5:45 PM** unless otherwise indicated on the school calendar. On early dismissal days, children must **bring a packed lunch**. Each afternoon we will provide a snack, spend time outside, and work on homework. We will also spend some time playing games, reading, working on art activities while encouraging each other to show positive, friendly attitudes!

Our *typical* daily schedule looks something like this:

2:40-2:45 Students sign in and prepare for our afternoon time together.

2:45-3:15 Students go outside.

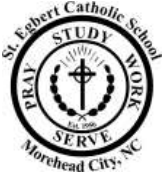
3:15-4:15 Students are inside for homework time and activities including games, puzzles, coloring, art activities, etc.

4:15-5:45 Students go back outside, weather permitting. Outdoor play includes, but is not limited to: swinging, walking, jumping rope, etc. and team-type sports such as kick ball, basketball, four square, “pick up” football, soccer, tennis, etc.

Note: Flexibility in this schedule is necessary due to the amount of time needed for homework as well as weather. If it is really pleasant outside, we may work on homework in the wide open spaces of the outdoors. As it gets darker earlier, we may need to work inside a bit longer. As stated earlier, flexibility is the key!

When you drive up to the front of the building, please check the front doors of the school for the **GREEN SIGN**; if you see the sign hanging, we are **OUTSIDE** and you will need to drive around back to the playground on Shepard Street for pick-up. If someone other than a parent or guardian is to pick up a child, please write a note to let us know who it will be and remind them to have an ID with them.
